

Central Virginia Bankshares Declares 2nd Quarter 2007 Dividend of 18 Cents

POWHATAN, Va., April 30, 2007 /PRNewswire/ -- The board of directors of Central Virginia Bankshares, Inc., (NASDAQ: CVBK), at its April 17, 2007 meeting, approved the payment of the regular second quarter cash dividend of \$0.18 per share. The dividend will be payable on June 15, 2007 to shareholders of record May 31, 2007.
